Oral Health during a Hospital Stay

Following a recent Healthcare Improvement
Scotland Care of Older People in Acute Hospitals
unannounced inspection in ARI, an improvement
action plan was drafted and a short life working
group set up, to take forward the action required.

The inspection found that improvements should be made to the screening of patients on admission, including their oral health status, oral care needs, and that person centered oral care plans should be routinely completed, recorded and carried out.

Kerry Hobbs, Senior Dental Officer, and Karen Tosh, Public Health Practitioner – Advanced, representing the Oral Health Improvement Group, were invited to attend the working group and after lots of discussion and testing, developed guidance documents that all care staff within a hospital setting would be able to use.

The Best Practice Statement provides the standards required for the oral health care for all patients within NHSG hospitals. The BPS is a short, one page, double sided guidance endorsed by NHS Grampian for all nursing and care staff. All wards will be provided with the document and it will be supported by training for all staff on the wards and as part of other oral health training including under graduate and HCSW induction training. These standards are also in line with the National Caring for Smiles Programme which is practised in nursing and care homes across Scotland.

2. Plan of Oral Care – assessment and planning guide.

The guide will be the daily working tool to be used by all nursing and care staff. It will be followed as part of the initial assessments done on admission to hospital. The guide will prompt and facilitate an oral health risk assessment and the development of personalised oral care plans.

In line with other training within the hospital, a tool kit talk for oral care during a hospital stay has been developed to support staff to deliver training within the ward setting. No longer than 30 minutes long it covers all the essential information and practical skills required.

4. Oral Health Training within Hospitals

Training support to be provided to hospitals across Grampian including working with identified wards to promote the BPS, Plan of oral care and tool kit, and providing in-situ training, advice and support to staff to improve oral health care within hospitals. Dental Public Health are looking at a proposal to provide this next year.

Oral Cancer Campaign – Let's Talk About Mouth Cancer

Check for Mouth Cancer - Taxi Launch

On 5th December 2019, NHS Grampian launched the next phase of its mouth cancer awareness campaign with the introduction of a taxi cab which has been specially branded with key messages to encourage everyone to 'check their mouth' for signs of mouth cancer. The taxi with its 'Check for Mouth Cancer' livery can be seen throughout the Aberdeen city area for the next 12 months.

The taxi, and its striking messages, aim to prompt conversations, and passengers will be able to ask their driver for information about the campaign and its messages.

NHS Grampian, in partnership with the national charity Let's Talk about Mouth Cancer (LTAMC), spearhead the local campaign to highlight oral cancer and the importance of checking your mouth regularly.

Jonathan Iloya, Consultant in Dental Public
Health for NHS Grampian said: "This debilitating
and highly disfiguring disease is often ignored,
although the number of new cases has increased
by 80% in Grampian in the decade to 2015.
Similarly, deaths due to mouth cancer are on an
upward trajectory in Scotland and these trends
are usually related to deprivation."

"This campaign raises public awareness about how to check your mouth for signs of cancer and to consult your dentist or doctor if you spot anything unusual such as lumps, red and white patches and ulcers which do not heal within three weeks. Early detection and treatment is vital for improving mouth cancer survival for patients affected by the disease."

"The campaign is one element of the strategy that aims to reduce incidence of the disease. We are also working on changing lifestyle behaviours associated with mouth cancer such as smoking and the use of tobacco and excessive alcohol consumption. It is also important to routinely visit your dentist as they have a key role to play in early detection of suspect lesions."



- * 5 hours of verified QI activity per participant. Survey is quick and easy to do
- * 1 lead person in a practice
- * An improvement action plan to be uploaded no later than **30 June 2020**

Enhanced Skills in Domiciliary Care

NHS Grampian are looking for expressions of interest for listing as a dentist with Enhanced Skills in Domiciliary Care in Grampian.

You will be required to meet certain criteria as listed in Annex A of PCA(D)(2019)(9) (available at www.sehd.scot.nhs.uk/pca/PCA2019(D)09.pdf) and, following an initial interview, you may be required to complete a programme of enhanced training and mentoring. Attendance at the NES course and Public Dental Service (PDS) monitoring sessions will attract an attendance fee payable at the CPD Allowance (CPDA) rate.

Following completion of training and award of a Certificate of Completion by NES, you will be invited to a final interview and, if successful, designated as a Dentist with Enhanced Skills in Domiciliary Care (domiciliary care dentist) and assigned a care home(s).
