Progress Report

The purpose of this report is to ask the NE Alliance to review and endorse the approach to engagement on the principles and priorities of the NE Alliance in year one.

Summary of Key Information

1. Introduction

Following the workshop of the NE Alliance members and subsequent meeting with the Advisory Board a workplan has been developed for consideration by members (item on agenda).

During the development session NE Alliance members created a set of principles to underpin our way of working in partnership. It was agreed that the principles would be in draft to enable partners to engage within their organisations over the course of the first year of the Alliance. It is for members to decide how best to engage within their organisation. The following sets out the agreement within the health and social care system and support available.

2. Proposal

Following engagement with the Chief Officers of the Health and Social Care Partnership it was agreed that engagement should take the form of a cascade approach to enable greatest participation. Each Portfolio will identify 'Champions' for their area who will receive training and will be supported to engage within their sector.
